# 3) Insurance Presentation - Scott Carson (For Discussion Only)

Scott Carson was at the meeting to update the board on what is going on with the employee's health insurance. We had an employee committee that started back in February looking to see what was out there. We got some input from them and we went back and trying to look to improve the situation. Basically, the biggest complaint was spending money on insurance. Scott had went back and tried to find the same benefits that we had before with less cost. The Affordable Care Act was created to reduce the number of companies in the insurance world and they've been doing a good job. Most states have two or three different places to choose from. Scott found some different plans that are out there. He's checked with other plans and he's gone thru this with Joe. There's Etna, Metropolitan, Signa, a couple of other ones for state employees. There are also self insured plans.

Scott also looked at Allstate. There wasn't enough to change it. The Doctors would all changed also. He said if it works don't change it. That's where we're at.

Scott passed out the plan. The plan itself did not change except the name of it. These rates are less than what we had before.

There are 14 pages in the summary.

Scott said that if anyone had any questions about that, they could call him. With no change, most everyone is familiar with the plan.

Joe said that in a nutshell the plan goes up \$1100 a month and the employees pick up the rest of the cost. We're gong to stick with the plan that we currently have. This is one of the smaller increases that we've got. After two years, Scott will do some research to see what's out there.

On motion of Ryan Wheeler and seconded by Lindsey Dalley, the Board voted 4-0 in favor to accept the proposed insurance plan presented by Scott Carson.
