4) Manager Reports

Office Manager

Jeannie had the financial dashboard in the Managers' Packets. This is for the end of the year. There was a couple of things on the dashboard. Chad is on vacation. These are tentative numbers. Operations are down for June. Appreciation is up. It looks weird because of the billing period. Revenues were up a little. Everything looks good.

Assistant General Manager

Lon said that in July Arrow Canyon #1 pumped 86,033,000 gallons of water.

Baldwin pumped 23,266,000 gallons of water for a total of 109,299,000 gallons of water.

Lon also talked about the 12"/14" to 24" Inter-Connects

Staff has completed two of the three interconnections between the 12"/14" and the 24" to assist in keeping some water flowing to the lower valley if the 24" is shut down due to a leak, or vice versa.

There was a lot of talk about the power outage we had. Luckily, we had a few generators.

We have two diesel tanks. We have a few vehicles that take regular gas. Hughes Oil is very good about keeping our fuel tanks full.

Lon talked about Arrow Canyon #2. It's down right now. It is capped to keep it clean so we can't sound it. Right now, we're only running Arrow Canyon #1.

Arrow Canyon #2 will hopefully be up and running at the end of the month. There was a lot of talk about this.

General Manager

Joe said that our County Commissioner is going to come out here on the 30th.

Shani Colemean is the head of Economic Development. She is going to come out and look at the Main Street project. She's going to see if she can get some more money for the Main Street project and some for other things also.

Joe explained to the directors how our new rate tier works.

The Governor's Office offered Joe to sit on a panel for economic development. Jason Cooper asked Joe if he would do it, but the date was changed by the Governor's Office. Joe will be in DC that week so Joe Phillips said he would fill in for Joe.

We are waiting to get responses from the businesses we sent the 2022 Business Impact Statements to. We sent out the 2022 Business Impact Statements and we should have all of their responses by August 19th. We will discuss this at the September 8th meeting.
