Charges for ALL water usage will be in accordance with District overage rate scale in effect at time of usage. Changes in service or use which may pose a threat of contamination or pollution to the district distribution system under the established Backflow Prevention Program will result in application of rates and requirements outlined by District policy.				
All water bills are due and payable upon receipt. A bill will become delinquent if not paid within fifteen (15) days from the date on which the bill was mailed. Late charges will be calculated on any outstanding monthly balance at the rate of 10% per month. If a monthly bill plus the late charge is not received by the district on the 24 th day following the date on which the original bill was mailed, then the service will be disconnected, and ALL accumulated charges PLUS a twenty-five-dollar (\$25.00) dispatch fee must be paid prior to the service being restored. Failure to receive a bill does NOT remove responsibility for payment
