**ALL WATER BILLS ARE DUE UPON RECEIPT.**

A bill will become delinquent if not paid within fifteen (15) days from the date on which the bill was mailed. Late charges will be calculated on the current monthly balance at the rate of 10% per month. If a monthly bill plus the late charge is not received by the District by the 24<sup>th</sup> day following the date on which the original bill was mailed then service will be disconnected, and all accumulated charges PLUS a twenty-five dollar (\$25.00) dispatch fee must be paid prior to the service being restored.

**Failure to receive a bill does not remove responsibility for payment.**

**A non-refundable application fee of \$25.00 will be added to your first bill.**
